# IV. Schooling

(i) Schooling of the children of foreign nationals

As of 2020, there are 338 kindergartens, 189 compulsory education schools (including 97 regular primary schools and 92 regular junior high schools), 17 regular senior high schools, 18 secondary vocational schools (excluding technical training schools), 4 special education schools and 11 higher education schools in Weihai.

Current length of schooling: for compulsory education, 5 years of primary school education and 4 years of junior high school education; and 3 years of senior high school education. An academic year is composed of two semesters of about 20 weeks. The first semester is from the beginning of September to January of the following year; the second semester is from February to July. Summer vacation and winter vacation will last for about 12 weeks during the

stage of compulsory education and about 10 weeks during senior high school years.

School-age children of foreign nationals residing in Weihai may apply for a student residence permit in accordance with the Provisional Measures for the Administration on Acceptance of Foreign Students by Primary and Secondary Schools (Decree No. 4 of the Ministry of Education in 1999) in order to be enrolled at a school that is qualified to accept international students in the place of residence or a school for children of foreign nationals in Weihai. Original passports shall be provided for enrollment.

## VII. Foreign marriage registration

The application for registration of marriage between a foreign national and a Chinese citizen with registered permanent residence in Weihai shall be submitted to the marriage registration office of the Civil Affairs Bureau of the country where the Chinese citizen is registered as a permanent resident.

## (i) Application for marriage registration

Criteria: 1. The Chinese citizen is registered as a permanent resident in the area of jurisdiction of Weihai.

- 2. Both parties of the marriage shall jointly submit the application for marriage registration to the marriage registration office on a voluntary basis.
- 3. The male applicant shall reach the age of 22 and the female applicant must reach the age of 20.

- 4. Both parties of the marriage shall have no spouse.
- 5. Both parties of the marriage shall not be the lineal relatives by blood or the collateral relatives by blood up to three generations.
- 6. Both parties of the marriage shall not be suffering from any disease which is medically regarded as rendering a person unfit for marriage.

- Application materials: 1. The valid passport or other international travel documents of applicant
  - 2. The certificate issued by a notary organization or authorized organization of the country where a party resides and accredited by the embassy (consulate) of China in the country or the embassy (consulate) of the country in the People's Republic of China; or the no spouse certificate issued by the embassy (consulate) of the country in the People's Republic of China. Relevant certificates issued by countries that have no diplomatic relations with China shall be accredited by the embassy (consulate) of a third country that has diplomatic relations with both the country where a party resides and China in the country where a party resides and the embassy (consulate) of China in the third country or the embassy (consulate) of the third country in China.
  - 3. Three 2-inch recent half-length and bareheaded group photographs of both parties of the marriage (obtained through the free photo service provided by the marriage registration office or provided by applicants)

## VIII. Consular legalization

Basis of establishment: LBH [2006] No. 769 and [2010] No. 897 documents of the Consular Department of the Ministry of Foreign Affairs

Criteria: The applicant shall submit notarial deeds or other certificates in compliance with the requirements of consular legalization

Application materials: 1. Application Form of Consular Legalization of the Embassy/Consulate of the People's Republic of China

- 2. Original valid documents for consular legalization (unlimited notarial deeds or other certificates)
- 3. Two copies of the valid passport of the applicant, if the applicant is a foreign national
- 4. Other documents required by the embassy of the country to which the application is submitted (for details, visit the consular service website at http://cs.mfa.gov.cn/ and refer to the regulations for consular legalization of foreign embassies (representative offices) in China)

#### Procedures:

- (i) Procedures for countries as applicants:
- 1. The applicant submits relevant documents based on the country to which the application is submitted and categories of legalization.
- 2. The Integrated Foreign Affairs Service Window on the third floor of Weihai Government Service Center receives the application.
- 3.An officer of the service window will conduct initial examination of the documents and the director in charge of the service window will review the documents; the leader in charge of filing and signing of the Legalization Office of the Consular Department will finally review and sign the documents.
- 4.For single legalization, the applicant will be notified to collect or receive the documents via SMS messages after the service window produces certificates and completes the procedures. As the documents submitted for double legalization will be sent to general consulates in Qingdao, the applicant will be notified to collect or receive the documents via SMS messages after general consulates complete the returning and closure procedures.

### Processing time limit:

Single legalization: 4 working days for regular services; 2 working days for express services

Double legalization: subject to the actual time needed by consulates to complete the returning and closure procedures (working days of the service window + working days of consulates + express mailing time)

- (ii) Procedures for countries as agencies:
- 1. The applicant submits relevant documents based on the country to which the application is submitted and categories of legalization.
- 2. The Integrated Foreign Affairs Service Window on the third floor of Weihai Government Service Center receives the application.
- 3. An officer of the service window will conduct initial examination of the documents and the director in charge of the service window will review the documents.
- 4. The registration form for the document to be legalized, the official letter and all other documents shall be provided and sent to the Legalization Office of the Consular Department of the Ministry of Foreign Affairs. The applicant will be notified to collect or receive the documents after the Legalization Office of the Consular Department completes the returning and closure procedures.

#### Processing time limit:

Single legalization: subject to the time needed by the Legalization Office of the Consular Department to complete the closure procedures (generally, 11 days for express services and 15 days for regular services)

Double legalization: subject to the time needed by an embassy to complete the closure procedures (Subject to the actual time needed by an embassy due to adjustments in legalization time needed by an embassy in China from time to time as a result of many factors.)

#### Fees:

(According relevant regulations, agencies will charge RMB 90 as the agency fee in addition to the legalization fee collected by the Ministry of Foreign Affairs and an embassy.)
